Camping trailer and RV parking sites are restricted to the Campground only. ***There will be \$50 per site non-refundable deposit to hold your site.***

There are two types of sites available:

1. Compound Parking- (Electricity Only)- Spaces are approximately 20' X 40' or as grouping configurations are approved by Iowa Speedway. These spaces are \$30 per night. Slide outs (one side only) and Air conditioners (max 2) are included.

Compound camping on site, sewage dumping facilities are located on the Speedway Grounds. Commercial pumping and water filling will be available for an additional cost. Showers and restrooms are available on site.

2. Primitive- No Electricity, No Water and no sewer are available- Approximate size 20' X 40'. These Spaces are \$15 per night.

CAMPGROUND RULES AND REGULATIONS

1. No Campground site can be sub-let to anyone for any reason or purpose.
2. Only ONE car, truck, SUV, etc. is allowed on site. There will be a permit required (and fee) for only one recreational vehicle.
3. Open Burning is allowed in approved fire pit.
4. Pets are allowed and must be contained or tethered at all time. YOU are responsible for cleaning up after your pet.
5. Issued permits must be displayed so as to be visible to Emergency/Security/Fair personnel at all times.
6. All units must be checked in prior to parking or setting up on designated sites.
7. All damages to electrical pedestals, water hydrants, sewage receptacles, electrical panels, showers, toilets buildings, etc. must be immediately reported to PGI and a City of Newton representative. (Grey water cannot be dumped on the ground- parties violating this will be fined and possibly removed from the Speedway without refund of unused portion of facility rent.)
8. All Campers must comply with all State and Local Health Standards and keep their sites and surrounding areas neat and clean of all garbage and rubbish
9. City of Newton or Iowa Speedway reserves the right to, at all times, revoke any permit and evict the permittee and all other persons on site if there is dangerous, threatening, loud, obnoxious behavior or any behavior that interferes with the health, safety and welfare of other campground permittees. Quiet times on the grounds are from 11 p.m. to 7 a.m.
10. Weapons of any kind, drones, remote control helicopters, planes, other remote controlled devices and illegal substances are all prohibited. Anyone caught using these items will have them confiscated, and a citation may be issued by city or county law enforcement.
