



2020 PGI ATF License Use Agreement

The Pyrotechnics Guild International, Inc. (PGI) and _____ (Member) enter into this agreement allowing the non-ATF licensed Member to be able to transport their regulated fireworks to the PGI convention using the privileges of the PGI ATF license.

The Member certifies that they meet all of the eligibility requirements listed below. The Member further agrees that if any of the conditions change so that they are not able to meet the requirements below, that they will immediately notify the President of the PGI verbally and follow up with written notification within 24 hours.

To be eligible to enter into this agreement, the Member certifies:

- Their PGI membership is current and in good standing.
- They are registered as a primary member to attend the PGI convention.
- They are not required to answer yes to any of the ATF license qualification questions.
- They have signed and properly executed the PGI Waiver of Liability.

By entering into this agreement, the PGI agrees to add the Member as a Responsible Person to the PGI ATF User License with the following restrictions:

The sole responsibility of the Member is the safe and legal transport of their fireworks to the PGI Convention, on or before August 17, 2020. The Member may not transport fireworks or any other type of regulated explosive for any other purpose using the PGI license.

The Member may not exercise any other privilege of a Responsible Person on the PGI License, including but not limited to purchase and/or acquisition of regulated material, adding or making changes to the license, contacting the ATF regarding the license, or representing the PGI in regard to the license.

The Member understands that this agreement is a privilege and may be terminated and modified at any time by the PGI President or PGI board with or without prior notice. The member agrees that the PGI is not liable for any damages if this agreement is terminated or modified for any reason.

The Member understands that by using the privileges of the PGI ATF license and this agreement, they are in fact representing the good name of the PGI. The Member agrees to conduct themselves responsibly and with good character while exercising the privileges of this agreement, and while traveling, to follow all traffic laws and drive conservatively and safely.

The Member understands and agrees that violating the terms of this agreement, or harming the good name of the PGI in any other way will lead to disciplinary actions, including but not limited to suspension or termination of PGI membership, and civil liability to restore the good name of the PGI.

The Member agrees that any action or inaction on the part of the Member that leads to fines, penalties, litigation, or any other cost are the sole responsibility of the Member. The Member further agrees to pay for all collections costs and attorney fees associated with the PGI recovering these costs from the Member.
